Update: USFS Ranger Updates (Erin Black, USFS)

- Hiring of FMO This isn't time of year. Received a very short list. Will look again in October.
 Will have an AFMO detail into position.
- New Chief Randy Moore career agency employee.
- Lewis River Rec Area going well from management perspective. Receiving some complaints for spontaneity.
 - FS is being flexible allowing folks to drive down to cell service to get a ticket and FS writing out pass to put on dash
- No active Timber Sales due to limited operating period, market, and work force. Should see pick up soon.
- Big Hollow Planning Project comments were supportive. Finishing up NEPA decision.
 - Roadside Salvage logging could start soon.
- Upper Wind finishing up this month
- Jay MARS partnership working with Dave Olson, Sam Grimm on presale work.
- Huge increase in recreationists.
- Comment from Gary Ebikes on hiker trails no one knows they are restricted. Have seen more out there and there are no signs. They are going too fast. There will be accidents.
- Sue New Science Findings (OSU newsletter) is about social media and recreation.

- Working to unite ecology and economics for sustainable forestry
- We were focused on detecting and suppressing fire easy in frequent fire areas low fuels and right structure – but didn't maintain this level or structure
- Large and Intense fires today
- West & Intermountain West Millions of acres need treatment
- -Greg Aplet, the Wilderness Society
- -Susan Jane Brown Environmental Law Center
 - Aggressive logging not sustainable disappearance of OG forest
 - Public trust lost
 - NW Forest Plan
 - Harvest fell to 3 billion board feet
- -Mark Webb Blue Mtn Forest Partners, John Day
 - Lose forest to fires partly due to shutting down logging
 - Fuel buildup, warming climate
 - Majority is high severity fire
 - More people in harms way, and harm is getting worse

- Fire adapted ecosystem houses are not
- Weaverville The Watershed Center Nick Goulette
 - It will take generations to fix this
 - Tools = Thinning, Prescribed Fire
 - With fuel treatment, fire will head into treatment, flank and lay down
- -So much material start with mechanical work and reintroduce fire or allow fire to reintroduce itself
 - Need market development, mills need to retool
 - Restoration retain oldest, biggest trees, thin small trees
- -Collabs social consensus that provides license for agency to move forward with programs
 - Need is great too many barriers
 - FS not staffed or funded appropriately
- -Chris Topik TNC
 - Spending up to 57% of budget on fire coming out of management budget
 - Wildfire Emergency Fund to stabilize management budget
 - Now need to invest in Fire Adapted Community (FAC) work
- -Dylan Kruse, Sustainable Northwest
 - Small low-value wood
 - Vaagen Bros Colville retooled mill
 - Russ Vaagen Need scalable solutions
 - New products: Biomass, wood chips, cross-laminated timber
- -Jerry Multiple values fuels, wildlife need interdisciplinary groups
 - Need smoke and controlled fire before get Megafire
- -Nick Resilience of landscape and community are the same thing

Discussion:

- -Mary how much do you think small communities in WUI have ability to change the size of fires?
- -Ever expanding WUI landowners, commercial timber companies
- -Mary has links to helping communities become more wildfire adapted
 - ~80-90% of wildfires are human caused
 - 1990-2010 41% increase in new houses in WUI
- -Jim need to tell people where local forests are in fire regime and landscape
- -Tom County has been actively raising awareness
 - Brought Era of Megafires film, Paul Hessberg
 - No overarching group does not gel unless one group leading effort
 - Mid-Columbia Fire Prevention Group is coming online again
 - Firewise program is active
 - Working with UCD to create sign

- Eagle Creek Fire 4 years ago people forget
- Put group together to develop some kind of a plan
 - o Community initiative with lots of different players
 - Grant money to help prepare homes for wildfires
- -Jeremy as Jerry said, responding to and treating depends on environment
 - Building codes and growth planning in film are different than OR/WA
 - Takeaway industry is key partner; economic end use is cost prohibitive
- -Andrew we are not in chaparral forest but do have persistent winds long dry, hot summers
 - This is a unique location need to push envelope
 - Climate change and forest inventory data show need to treat 30-50% of landscape
 - Nowhere near what currently happening
 - Going to have to challenge what is appropriate for the future
 - Lots of constraints need to be bold
- -Mary Repar basis of trust is important between public, agencies, stakeholders
- -Jay comment on message of film
 - Recently read article in The Hill on Rx Burn Policy message seemed off
 - Need to start with basic message for audience especially if high level, policy changing
- -WAFAC Washington Fire Adapted Communities promoting this work statewide
- -"How do you want your smoke" ~Paul Hessburg
- -Erin –
- Rx fire does not seem controversial from current comments
- This may change due to more smoke from longer wildfire seasons
- Liked Jerry's comment: Only one outcome if focus only on fuels reduction
- -Dave Olson -
 - More stable budget
 - Trying to build capacity with others, like DNR
 - Finding harder to do than hoped. No capacity out there.
- -Tom Linde -
 - There is not a short-term fix
 - Have to continue to manage for fuels because constantly growing and changing.
- -Mary seems the Forest is having identity crisis
 - Timber or ecosystem management
 - Middle path opportunity to manage for multiple uses
- -Matt Little hope to find funding and resources

Presentation: Little White Planning Area (USFS Staff)

- Current timber target 55MMBF
- Landscape approach considering climate change
- Incorporate DNR's Landscape Evaluation
- Northern Spotted Owl in watershed
- Riparian strategy likely to continue with previous strategies
- Almost all land is matrix
- West of lava beds is Late Successional Reserve approximately 2 stands
- Stand Exams surveys happening
- National Forest boundary
 - considering shaded fuel break
 - working with the Willard Fire Chief
 - Actions of Community Wildfire Protection Plan
 - May become Categorical Exclusion
 - May look at Prescribed Fire
 - Looking at Fire refugia concept best pockets to preserve or enhance them
- At the recent landscape characterization team meeting, they looked at resources in watershed. Identified this project would be a good collaborative opportunity.

- In field this summer, collecting data
- Project will be the focus this fall, winter to spring define proposal
- Draft Environmental Assessment Oct 2022
- Final Decision Feb 2023
